The Request for Proposals was posted on SEEK, UpWork, and shared on Facebook to both the MDS and WDS. Emails were also sent throughout the University of Minnesota through known contacts. The RFP was also sent directly to individuals who declined to submit a proposal:

Sandra Hunt-von Arb was too busy to take on another project.



Mike Sweet Well, I am down to the last hour before I must leave for the day and will then not be able to cast my opinion, unless I want to do it late tonight. I have struggled with this vote because the rating I did brought points very close; I will send Angela my form after this post. Both potential contractors have strengths and relative weaknesses, and I suspect both are acceptable. I considered Nitid to have greater strength (i.e., experience) in all the contracting and technical aspects of the software related areas. I found Crystal to be stronger in knowing the resource, the players (i.e, us, DNR, museum people, MN in general), and has a better chance of understanding our community and communicating with it. I am concerned that Nitid will overwhelm volunteers (us) which may result with a product that may be difficult to work with, over time; this only relates to the time any of us have to digging in and ensuring we track, understand, and push back when necessary. Similarly, I question whether we would be able to have documentation that we could manage without going back to Nitid and paying more for its help. On the other hand, I have concern that we may accept the recommended software that Crystal identified. I know nothing about it other than what has been discussed; I should have done some research on the software but...too late now. My only hope is that if we choose PastPerfect and are later unhappy with it, that all the data can be easily transferred to a new choice, including a web based option. With all that mumbo jumbo and hesitation, my vote is ... ta, ta, ta, dah (the trumpets sounding).... to accept Crystal's proposal.
