They asked for Friday 5/20 field ID (3-4 hours) and survey training, and Sunday 5/22 MDS table (indoors?) at Treasure Island Casino (in Red Wing, 46 miles southeast of Mpls.). John will lead; Curt will volunteer.

Dianne- asked about elections- We vote for BOD at annual meeting, then officers are set at first meeting (in Feb.) of new Board.

Leah- talked with Tony, and he is interested in BOD. Dianne will call him.

Not continuing on BOD: Mitch, Amy Jo

Curt- minimum number on BOD: need to cover the officers, 4 people Mike- to change the by-laws, we need to vote on it at an annual meeting; so make it an action item for 2022 to review the by-laws. Consider reviewing term limit (presently set at 5 consecutive 2-year terms). If there is a vacancy, the process is for BOD to fill that until the end of that term.

Curt- Angela did great work on writing the MDS by-laws! Preferred size of BOD at 14 people, but not mandatory.

Perk- other organizations combine secretary & treasurer

Kat- Do reach out to recruit new Board members!
